Dr. B. Srinivas welcomed the participants and requested NBEMS officials to give a presentation regarding the generation of State Specific Merit List for NEET-PG 2024. Prof. Subodh Kumar after giving a brief introduction on the issue requested Dr. N. Iboyaima Mangang, Additional Director, NBEMS to give the presentation about State Specific Merit list in NEET-PG 2024. The copy of the presentation made by NBEMS is enclosed herewith.

The participants discussed the matter in details. The following decisions were made:

1. There are a few states like Haryana and Goa who do not provide additional incentivized marks to any in service candidates in NEET-PG 2024. These states need not contact NBEMS for preparation of State Specific Merit List and the same can be prepared at their end as was done in the previous sessions of NEET-PG.
2. As requested by NBEMS, it would be desirable to have one-time registration for all rounds of counselling by the State Counselling Authorities.
3. It was suggested that the State Counselling Authorities may complete the registration process by 05th November 2024 (Tuesday).

4. The State Counseling authorities will provide to NBEMS the complete list of all candidates (in password protected MS Excel file) who are eligible and have registered for their state counseling in the desired format by 06th November 2024 (Wednesday) at ssr@natboard.edu.in .
5. The password for the MS-Excel file /documents should be sent separately at 9910365195.
6. NBEMS shall provide the State Wise Merit List within a week after receipt of the required data from the state counseling authorities.

8. The participants agreed to share the details of the single point of contact official with their name, designation, email id and mobile number as desired by NBEMS.

Dr. B. Srinivas informed the participants that the above-mentioned decision regarding submission of required registration data to NBEMS by the concerned State Counselling Authorities and timeline for submission of State Wise Merit List by NBEMS to the State Counselling Authorities will be published on MCC/NMC website and the same shall also be communicated to all the State Counselling Authorities by email.
